CONTRACT

T-Golden Tax Service Inc. follows standard operating procedure followed by Internal Revenue Service and State Department of Taxes in conformity with the standard and practice set by National Association of Tax Preparation NATP. Any tax you filed under the ERO and Tax specialist Tika R Timsina for the year you entered in with an agreement to file taxes may require future communications for tax purposes with you or IRS and are covered only if you paid fees. By signing this , You agree with us to use any type of payment collection system including credit, debit, check using the information you provided us here . You allowed us to be communicated in the following ways. The fee starts at \$200 for personal taxes and \$750 for business taxes and accounting is negotiable after it depending on how many forms you file or is this business and or personal schedule C only or both corporate and non corporate tax filing. If your tax issues caused us to spend more than 10 hours a year with the IRS or state department of taxes we will bill you \$1 per minute for any additional talk with them after this. This service is only available if you atleast file two consecutive taxes with us otherwise is \$10 per minute. Faxing and remote printing and other services with digital backup of pendrive or other forms printing a tax file charges follow the same process. You will be charged for it for the first two years and subsequent years at no charge. If you have our virtual or remote device please pay us any time within three years \$150 or return us with no damage within the year. Devices returned after a year will be charged.

By signing this you are aware that you were informed about it. T-Golden tax service will not enter to separate contract for transcript request online if required at any time during these three years if your tax issues arise for the issues only related to tax and income not for other purposes. T-Golden Tax

Service Inc and the preparer is not required to follow any order from any State including where you live other than Vermont. T-Golden Tax Service Inc and its representatives are here by waived harmless for any error reporting income to us by taxpayers and family or any outcome from preparation of returns including using your personal and family information or business information on third party tool, website, email and other paper digital or virtual or remote sessions or tax paper tax forms that can hold your information to process your return. If you dint give us asked information we are not required to prepare your return. Further, If you are not signing these documents we will not prepare your return. You can call us for FEDERAL and state tax file communication with our authority at 801-548-0477 and sign attached 8821 or 2848 under the same fees from the second year of entry to contract. We may retain your records until three/four/seven/unlimited years from the date of submission depending on the type and nature of tax you file and how you move forward with your tax situations. If we write a letter and give you we stopped serving you we will never again take you in our practice and this is our choice and write as tax preparer.
